Order Establishing Fishing Season 2019

Saginaw Chippewa Indian Tribe

Per Tribal Ordinance 11, Section 107 subdivision 2(B) the **2019 Fishing Season** shall begin **January 1, 2019** and will close on **December 31, 2019** unless ordered otherwise.

Licenses and Permits will be available at the Tribal Planning Department office starting January 2, 2019.
