Exemption (Form 3372), and the Letter of Authorization to the vendor/supplier of the tangible personal property that will be affixed to the real estate Retain a copy of the Michigan Sales and Use Tax Certificate of Exemption, the Tribal Certificate of Exemption and the Letter of Authorization.								
Construction projects spanning multiple years will require a new Tribal Certificate of Exemption at the beginning of each								
new year.
