# Merry Christmas and Happy New Year

The Michigan Department of Health and Human Services (MDHHS) issued a new emergency order Sunday November 15th 20202 - that enacts a three-week pause targeting indoor social gatherings and other group activities in an effort to curb rapidly rising COVID-19 infection rates. Under this order, indoor residential gatherings are limited to two households at any one time. The order is aimed at limiting residential and non-residential gatherings where COVID-19 spreads.

- Bars and restaurants will be open for outdoor dining, carry-out and delivery only.
- Gyms will remain open for individual exercise with strict safety measures in place.
- Non-tribal casinos, movie theaters and group exercise classes will be closed.
- Professional and college sports meeting extraordinary standards for risk mitigation may continue without spectators, however all other organized sports must stop.
- Colleges and high schools may proceed with remote learning, but must end in-person classes.

We still operate by appointment only. If you need to schedule an appointment please call 775-4595. If you need to pay your rent; you can still use the mailbox in the front foyer.




