### Can wet wipes or baby wipes be flushed down the toilet?

Contrary to what you may have heard, wet wipes, baby wipes, makeup removal wipes, and similar items are **not flushable**. Since wipes do not break down like toilet paper, flushing them can cause major clogs and blockages. Other items not to flush down the toilet include sanitary napkins, paper towels, facial tissues, feminine products, "flushable" wet wipes, broken toys, and disinfecting wipes. **Tenants will be charged for removal of these items from your toilet or pipes.** If you are unsure remember **"Don't Flush It"**.

### Concession Stand and Broadway Park Reservations

The Pavilion and Concession stand will be available for reservations starting **April 12th** for weddings, graduations family re-unions, and birthdays. Reservations require \$100 deposit and 48 hour notice. For more info please call Andrew at (989) 775-4595.

Due to COVID - Starting April 12th - Broadway Park bathrooms will be open Mon-Fri - 8am until 5 pm. The bathrooms will not be open on the weekends unless there is planned reservation. Please - Be Safe in the park.

## Pet Policy Reminders - Please clean up after your animals.

With the spring weather coming right around the corner; we are reminding you about some important points from the pet policy.

- **All pets must have a pet licenses**  
*Either from the Saginaw Chippewa Tribe or the county clerk's office.*
- **All pets must be current on their vaccinations.**
- **Dogs such as Pit Bulls and Rottweiler are not allowed**  
*Pursuant to Section 7.031 of Tribal Code Title VII.*
- **No pet should be left unattended,**
- **Only one pet per household**
- **Any waste generated by a pet must be disposed of promptly.**



## Nimkee Clinic Vaccination Samantha Chippeway (989) 775-4959

Studies show that COVID-19 vaccines are effective at keeping you from getting COVID-19. Getting a COVID-19 vaccine will also help keep you from getting seriously ill even if you do get COVID-19.

COVID-19 vaccines teach our immune systems how to recognize and fight the virus that causes COVID-19. It typically takes two weeks after vaccination for the body to build protection (immunity) against the virus that causes COVID-19. That means it is possible a person could still get COVID-19 before or just after vaccination and then get sick because the vaccine did not have enough time to provide protection. People are considered fully protected two weeks after their second dose of the Pfizer-BioNTech or Moderna COVID-19 vaccine, or two weeks after the single-dose Johnson & Johnson's Janssen COVID-19 vaccine.

**You should keep using all the tools available to protect yourself and others until you are fully vaccinated.** After you are fully vaccinated, you may be able to start doing some things you had stopped doing because of the pandemic. Household members shall include family members or any other persons living or residing at the above-described premises.
