We ask that everyone please clean up your yard of all debris including broken glass, cans, newspapers, plastic, rusted tin, old appliances, caps, bags, or old furniture. The Housing program offers "First Cut" as a free service for all Housing tenants. However; if your yard is full of too much debris, we will not cut your lawn and you will be given a strike letter. After "First Cut" - All tenants will be responsible for your lawn duties including debris removal, cutting, raking,


Pet Policy Reminders - Please Register your animals.

With the spring weather coming right around the corner; we are reminding you about some important points from the pet policy.

- All pets must have a pet licenses
 - Either from the Saginaw Chippewa Tribe or the county clerk's office.
- All pets must be current on their vaccinations.
- Dogs such as Pit Bulls and Rottweiler are not allowed

Pursuant to Section 7.031 of Tribal Code Title VII.

- No pet should be left unattended,
- Only one pet per household
- Any waste generated by a pet must be disposed of promptly.


Broadway Park Reservations Opening

Rental and Utility Assistance

Rental and Utility Assistance Now Available

The Saginaw Chippewa Indian Tribe's Housing Department is now taking applications from eligible renter households

Eligible households:

- Total household income is below 80% of the 2020 median family income
- A household member qualified for unemployment benefits, or
- The household has experienced a reduction in household income, or
- The household has incurred significant costs due to COVID-19, and
- The household is experiencing housing instability due to COVID-19
- The household is located in one of the following counties: Arenac, Gladwin, Gratiot, Isabella, Mecosta, Midland, Osceola, and Montcalm
- Members of the SCIT residing anywhere and meeting the above criteria

Types of assistance included:

- Rent arrears, utility arrears, water/ sewer, and trash removal arrears occurring after March 13, 2020
- Security deposit, and application fees
- Prospective rent, utilities, water/ sewer, and trash removal
