- All signatures must be signed by Native American youth (*between the ages of 12-20 years old*) whom is from a federally recognized tribe, a direct decedent or is eligible for K-12 services.
- Completed petitions must be turned in by petition due date of October 20, 2017 by 5:00pm, no later exceptions.
