## ORV Safety Education Requirement

**ALL ORV OPERATORS UNDER 16 YEARS OLD ARE REQUIRED TO POSSESS A VALID SAFETY TRAINING CERTIFICATE WHEN OPERATING AN ORV. TO OBTAIN A SAFETY CERTIFICATE, THE OPERATOR MUST TAKE AN ORV SAFETY EDUCATION COURSE AND PASS THE CERTIFICATION EXAM. THE OPERATOR MUST CARRY THE SAFETY CERTIFICATE ON HIS OR HER PERSON AND PRESENT IT UPON DEMAND OF A LAW ENFORCEMENT OFFICER.**
