The space includes the following areas,

- 3 Preschool classrooms
- 6 elementary classrooms
- Restrooms
- 2 full gymnasiums
- 1 weight room
- 1 stage area/multi-purpose area
- A multi-media area/library
- 6 special use rooms
- 21 office areas (approx. includes multi use areas)
- Food service area and storage rooms
- 1 main lobby entrance
