In consideration for allowing me to sell goods on Tribal land, and on my behalf, my personal representatives, administrators, and heirs ("Releasing Parties"), I hereby release, waive, covenants not to sue, hold harmless, and agree to defend and indemnify the Soaring Eagle Casino & Resort, Soaring Eagle Gaming, The Saginaw Chippewa Indian Tribe of Michigan, or their members, councilpersons, subdivisions, agents, or affiliates, including the Farmers' Market Task Force ("Released Parties"), of and from any and all claims, actions, causes of action, demands, damages, costs, loss of services, expenses or any compensation or relief whatsoever ("Claims") which now exist or which may later accrue as a result of my activity on Tribal land or any act or omission hereunder, including any and all Claims arising from strict liability or the negligence of any of the Released Parties related to such transactions, Claims attributable to bodily injury, sickness, disease, death, injury to, destruction or loss of tangible property, Claims of invasion of privacy, intellectual property infringement, or fraudulent business practices. Further, I shall pay the cost of any repair or replacement due to any damage caused by me, or my representatives to Tribal property. This release and waiver of all Claims and acknowledgment is intended to be as broad and inclusive as permitted by law. If I or another Releasing Party shall commence, join in, or in any manner seek relief through the courts, legal action or arbitration based upon any of the Claims waived, released, or forever discharged under this document, then the Releasing Party seeking such relief shall pay all expenses of the Released Parties, including attorney's fees, and costs. In addition to the foregoing, under no circumstances shall the Released Parties be liable for consequential, indirect, special or punitive damages of any kind in connection with its activities or omissions under this Agreement, regardless of whether such damages were foreseeable.
