### Vandalism against Tribal community and property prompts message of awareness

On Aug. 16, an incidence of vandalism to Tribal buildings and property were brought to the attention of the Tribal Observer.

The incident involved unauthorized access to a Tribal building where spray paint was used to damage the walls along with broken glass and destruction of recreation equipment.

Tribal Administrator Dustin Davis said the Tribal community generously supports many events and hosts important family gatherings that promotes the culture and lifeways, and when buildings, property and assets are abused, it can alter plans and limit use availability.

"Recently, two of our buildings incurred damage and property loss due to trespass, vandalism and theft. We have increased our building management walkthroughs to enhance security and maintenance efforts," Davis said. "To expand efforts to protect all Tribal buildings and property from illegal activity, we ask community residents to report any suspicious observations to our Tribal Police Department. Miigwetch for your assistance and support, community-based efforts are meaningful and encourage our togetherness."





Several areas of vandalism occurs in the men's bathroom inside the Eagles Nest Tribal Gym. Spray paint litters the walls, mirrors, and both urinals and toilets.

Saginaw Chippewa Police Tribal Observer press time. Captain Kelly Babcock said the detective assigned to the case turned up three alleged juvenile suspects and one suspect that was 18 years of age.

Interment will take place at Clinton Grove Cemetery, 21189 Cass Ave, Clinton Township, MI 48036.

#### **Special Elder and Mentored** Youth Deer Hunt 2025

Per Tribal Ordinance 11, Section 105 subdivision 6(B) the 2025 Special Elder and Mentored Youth Deer Hunt within the exterior boundries of the Isabella Indian Reservation and on designated Tribal Trust Lands outside the exterior boundries of the Isabella Indian Reservation shall begin Sept. 1, 2025 and will close on Sept. 3, 2025, unless ordered otherwise. Further restrictions shall be as follows:

- Tribal Member youth for the purpose of this hunt are defined as ages 10 to 17 years of age.
- Youth participants ages 14-17 must be accompanied by a Tribally licensed adult mentor at least 21 years of age under Tribal Ordinance 11.
- Youth participants ages 10-14 must be accompanied by a Tribal Licensed Parent or Guardian.

ersuant to Ordinance 11, Section 105, Subdivision 2(B): under 14 years of age must be accompanied by a licensed parent or guardian.

- The mentor is not allowed to carry any hunting device (firearm, bow or crossbow) in the field while accompanying the youth hunter.
- Ages 10-14 years are only eligible to use a bow for
- Ages 14-17 years are eligible to use a bow or firearm
- Tribal elders for the purposes of this hunt is defined as 50 years of age or older. The license for this hunt may not be assigned to a proxy hunter.

The 2025 Special Elder and Mentored Youth Hunt will allow for the harvest of one deer. Licenses and harvest tags are available now, at the Office of Tribal Licensing & Regulations at \$10 per harvest tag. Only one tag is allowed for this special hunt.

- All other portions of Tribal Ordinance 11 must still be followed. Please Refer to the Ordinance 11 on the Saginaw Chippewa Indian Tribe website for rules and regulations.
- Hunter orange is in accordance with Tribal Ordinance 11, Section 104 subdivision 5 and harvest reporting is to be in accordance with Tribal Ordinance 11, Section 105, Subdivision 5(B)

#### **Small Game Season 2025**

Per Tribal Ordinance 11, Section 106 subdivision 3 the 2025 Small Game Season within the exterior boundries of the Isabella Indian Reservation and on designated Tribal Trust Lands outside the exterior boundries of the Isabella Indian Reservation shall begin Sept. 1, 2025, and will close on March 31, 2026, unless ordered otherwise. The 2025 Small Game Season will allow for the bag limits as listed:

- Pheasants shall be limited to male pheasants only with a limit of five per day.
- Badger, beaver, muskrat, mink, pine martin, fisher and otter are all closed to small game hunting.
- Badger, beaver, muskrat, mink and otter will be open for Trapping Season. Bag limits per Trapping Season Order.
- Bobcat is limited to two tags only whether hunting, trapping or combination of seasons.

Small game species are defined in Tribal Ordinance 11, Section 103 subdivision 66.

Licenses are available now at the Office of Tribal Licensing & Regulations. \$10 per license. Animal harvest must be reported within 72 hours of take by phone, email, or online.

- "Other Indians" may not hunt on Tribal Trust or Tribal owned Fee Land. Other Indians as defined in Tribal Ordinance 11, Section 104 subdivision 52.

#### Migratory Bird Season 2025/2026

Per Tribal Ordinance 11, Section 109 Subdivision 3 the 2025/2026 Migratory Bird Season within the exterior boundries of the Isabella Indian Reservation and on designated Tribal Trust Lands outside the exterior boundries of the Isabella Indian Reservation shall begin Sept. 1, 2025, and will close on Jan. 31, 2026 unless ordered otherwise. The 2025/2026 Migratory Bird Season will allow for the bag limit as listed. NON TOXIC SHOT ONLY.

#### Migratory bird season daily bag limit:

- Ducks: 20\*
- Canada Geese: 20\*\*
- Mergansers: 10\*\*\*
- Woodcock: 10 • Mourning Dove: 25
- Common Snipe: 16 • Coots & Gallinules: 20
- Sandhill Cranes: one
- Sora and Virgina Rails: 20
- Ducks 20 per day, including no more than five each of
- scaup, black duck, pintail and canvasback. Possession limit is not to exceed two times the bag limit.

the following species: hen mallard, wood duck, redhead,

- \*\* 20 per day Canada Geese aggregate. Coot, gallinule, sora and Virginia rail is 20 in the aggregate.
- \*\*\*No more than five hooded mergansers in the aggregate.

Reporting within 72 hours of harvest is mandatory per **Tribal Ordinance 11, Section 109, Subdivision 5(B).** A small game license is also required as per Tribal

Ordinance 11, Section 109, Subdivision 2. Licenses are available now at the Office of Tribal

Licensing & Regulations. Fee is \$10 per license. "Other Indians" may not hunt on Tribal Trust or Tribal owned

- Fee Land. Other Indians as defined in Tribal Ordinance 11, Section 104 subdivision 52.

#### **Trapping Season 2024**

Per Tribal Ordinance 11, Section 108 subdivision 2, the 2025 Trapping Season within the exterior boundries of the Isabella Indian Reservation and on designated Tribal Trust Lands outside the exterior boundries of the Isabella Indian Reservation shall begin Oct. 15, 2025, and will close April 29, 2026, unless ordered otherwise.

- Badger and otter limit two per season (tag included with license). • Bobcat1 is limited to two tags only whether hunting, trapping or combination of seasons.
- Muskrat, mink, beaver, raccoon, fox1, coyote1, skunk, weasel and opossum will not have a bag limit for the trapping season.
- No conibare style traps larger than 220 size (7"x7" jaw) may be used on land unless made inaccessible to cats and dogs at ground level.

Licenses will be available starting Sept. 25, 2025 at the Office of Tribal Licensing & Regulations. Fee is \$10 per license.

#### **Deer Season 2025**

Per Tribal Ordinance 11, Section 105 subdivision 6(B) the 2025 Deer Season within the exterior boundries of the Isabella Indian Reservation and on designated Tribal Trust Lands outside the exterior boundries of the Isabella Indian Reservation shall begin Sept. 4, 2025, and will close on Feb. 1, 2026 unless ordered otherwise. Further restrictions shall be as follows:

- Sept. 4, 2025 Oct. 31, 2025 shall be bow only
- Nov. 1, 2025 Feb. 1, 2026 shall be bow or gun

The 2025 Deer Season will allow for the harvest of five deer as follows:

- Three antlerless\* Antlerless gives the ability to take an anterless deer or a deer with antlers less than three inches in length (Ordinance 11, Section 103, Subdivision 2)
- One restricted (restricted to four or more one inch minimum points on one side)
- One antlered (any size antlered)

Licenses and harvest tags will be available starting Aug. 21, 2025 at the Office of Tribal Licensing & Regulations \$10 per harvest tag. Only five tags are allowed.

"Other Indians" may not hunt on Tribal Trust or Tribal owned Fee Land. Other Indians as defined in Tribal Ordinance 11, Section 104 subdivision 52.

Per Tribal Ordinance 11, Section 105, Subdivision 5(B). Animal harvest must be reported within 72 hours of take by phone, email or online.

- Please Refer to the Ordinance 11 on the Saginaw Chippewa Indian Tribe website for rules and regulations.
- Hunter orange is in accordance with Tribal Ordinance 11, Section 104 subdivision 5 and harvest reporting is to be in accordance with Tribal Ordinance 11, Section 105, Subdivision 5(B)
- Tribal lands designated for hunting are provided by the map located at the Tribe's Planning Department.

Tree stands/blinds are only permitted on Tribal property one week before the start of deer season as stated above and must be removed one week after deer season close date as stated above; remaining items will be confiscated. No screw-in tree steps, spikes, etc. are permitted except bow/gun hooks. Tree stands/blinds must have name and address affixed in a visible area, or they will be subject to confiscation.

Licenses and harvest tags are available now at the Office of Tribal Licensing & Regulations at \$10 per tag. Only one tag allowed.

Other Indians" may not hunt on Tribal Trust or Tribal owned Fee Land. Other Indians as defined in Tribal Ordinance 11, Section 104 subdivision 52.

Per Tribal Ordinance 11, Section 105 subdivision 5(B) animal harvest must be reported within 72 hours of take by phone, email or online.



# "Maadizekwe Wiijii" offers cooking teachings through Native Connections

On July 14 and 29, Sam Anglin, traditional food educator at the Saginaw Chippewa Tribal College, offered a hands-on presentation through Native Connections and shared his knowledge on the spirit foods of our ancestors.

The "Maadizekwe Wiijii" or "She/he starts cooking" event encouraged families to get in the kitchen and embrace the roots of healthy living by looking at food as medicine.

Anglin is also a trained recovery coach who shares his knowledge learned regarding traditional food systems by bringing cultural teachings of "Mino Bimaadiziwin," the good way of life, into his culinary creations.

"I shared a discussion on how important the three sisters - corn, beans and squash - are when looking at indigenous gardening," Anglin said. "Reconnecting with those original sisters is a healing that helps us to recover from culinary trauma brought from the boarding schools and commodity food experiences.

"The trauma that started from the fry bread, where commodity foods like flour and lard did not help our people with health challenges of diabetes and high blood pressure. When

our children went through the boarding school, they were fed slop, scraps and food filled with carbs while are traditional diet was full of vegetables, fish and game."

Felicia Otto, Native Connections program coordinator, said working with Anglin for the Indigenous cooking demonstration was good medicine for the community.

"Events like this help keep our cultural connection, have health benefits, promote food sovereignty, and help plant the seeds in our community on food sharing goals that the Saginaw Chippewa Tribal College is doing and promoting," Otto said.

Native Connections brought this event to the community through its SAMHSA grant, which Otto said, "Helps our community reclaim control of our food systems."

Anglin commented about the great number of families in attendance, highlighting the elders and children family members together.

"Those spirit food from our ancestors were given in a good way and having elders there that encourage children to learn these healthy ways is inspirational to indigenous chefs everywhere," Anglin said. "Relatives who cook for us have a special place in our hearts and they pass on that blood memory in their cooking.

"I remember my grandma making banana bread that filled the house with such a happy

#### Manoomin Berry Sweet Treat Recipe

(Makes six 1/2 cup servings) Ingredients:

- 1 cup Wild Rice
- 1/2 cup sunflower seeds (shelled)
- 1/2 cup maple syrup
- 1/4 cup fresh blueberries
- 1/4 cup fresh raspberries (or strawberries)

#### Instructions:

- · Rinse rice two times in cold water until the water runs clear
- Add rinsed rice to three cups of cold water in a 3.5 qt. covered saucepan
- Bring to a boil, reduce heat to medium
- Simmer covered for:
  - Hand parched: 17-22 minutes
- Store-bought cultivated: 35-40 minutes, or until rise is tender.
- Once cooked, drain excess water and then cool to room temperature
- In a large bowl, combine rice, sunflower seeds, berries and maple syrup
- · Toss gently until well mixed
- Refrigerate and serve chilled.

aroma and it touched our loved ones in such a good way. It also passes those recipes on to a new generation."

Anglin mentioned the importance of using the Tribe's resources: The manoomin wild rice camp is coming up and the Saginaw Chippewa Tribal

College's Mishiike garden will be coming into harvest time.

"Our friends from Seventh Generation produce also good medicines here and they always share that in a good way so there is a lot of ways to enjoy healthy cooking on the Reservation," he said.

#### MICHIGAN INDIAN DAY

ACT 30 OF 1974

"The fourth Friday in September of each year shall be known as Michigan Indian Day. This date is not to be construed as a legal holiday."

Although Michigan Indian Day was enacted in 1974, it did not gain momentum until 2007 when the House of Representatives resolved the following:

Michigan Indian Day is an excellent opportunity for Michigan citizens to better understand and appreciate the many contributions that people of Native American descent have made to our state.

The State of Michigan has the ninth largest population of American Indians in the country - more than 125,000.

Native American people have made vast contributions to the landscape, culture, history, politics and economy of Michigan.

Today, Native American people significantly contribute to environmental protection by setting an example of good stewardship, intergovernmental and international accord to oppose diversion of Great Lakes Basin waters.

Michigan should designate a day to focus attention on the many cultural and historical contributions of Michigan's Native American community.

As a sovereign nation the Saginaw Chippewa Indian Tribe of Michigan recognizes and celebrates this as an established Tribal Holiday.

On Aug. 23-24, hundreds of Tribal and community members came together on one of the last summer weekends as students return to school. The People's Traditional Powwow celebrated its 19th annual gathering at Seventh Generation wooded area, located at 7957 East Remus Road in Mount Pleasant.

The Anishinaabe Ogitchedaw Veterans Warrior Society led the Saturday grand entries at 1 and 7 p.m. on Saturday and 1 p.m. on Sunday.

Council Member David Merrill Jr., a veteran from the U.S. Marine Corps Reserve, participated in the honor guard and as a men's traditional dancer.

"My understanding of the eagle staffs is they were a part of tribal history at important meetings and events. They were present when clans gathered at ceremonies and treaties with other governments and they served to represent the people," Merrill said.

Merrill continued, "This is one of my favorite traditional powwows because it's comfortable out (there) with everyone dancing for the people. It's not about the powwow money or competition here

- it's about hanging out with family and visiting with our community members."

Shoshone Paiute tribal member Jason Whitehouse provided emcee duties. He also said this is one of his favorite powwows.

"I love the setting and we get a good turnout of dancers, drummers and community in attendance. It reminds me of when I was a kid when I would go to the old school style powwows," Whitehouse said. "Back in the day, we would powwow where there were a lot of trees, and it just brings out the traditional in everyone. The smaller arenas are more personable and were right up close to see all the action of both the dancers and drummers."

Similar to many cultural events, traditional Native artisans joined with food vendors to provide a well-rounded experience for the crowd.

SCIT Member Sam Anglin, traditional food educator at the Saginaw Chippewa Tribal College, was on site selling Indigenous creations from his stand.

"I've been able to talk to many people about the spirit foods of our ancestors and to share some Indigenous food knowledge with them," Anglin said. "We have our manoomin

Everyone has been curious on returning to the good food provided by the Creator and the healthy ways it can be prepared."

Warpaint from North Carolina served as the host drum. River Wild from Michigan was, once again, chosen as the co-host drum.

Cultural Representative Daniel Jackson said this year's invited drums were local drum Mountain Town and Eagle Flight from First Nations

London, Ontario.

Nathan Isaac of Rezonance Productions provided sound support for the weekend event. The drums resonated throughout the powwow grounds thanks to Isaac.

RJ Smith kept the dancers moving with many spot dances and specials as the arena director, and Head Veteran Ray Cadotte was on site for all grand entries.

The Jackson family generously sponsored the hand drum contest. It was won by Caden Pego with Eagle Flight Duo taking second place.

Four lucky youth also left happy after the Jackson family bike giveaway.

Seventh Generation, said the powwow is one of the ways her family gives back to the community.

"My dad (former Council member Delmar Jackson Sr.) raised us that way and we are supposed to give back to our community and always take care of those who need it the most," Jackson said. ### Honored Veteran Buck Richardson receives recognition at retirement ceremony

The Department of Veteran Affairs capped off their week-long tribal veterans training by honoring W.J. "Buck" Richardson at Soaring Eagle Casino & Resort on Aug. 22. Richardson is the minority veteran coordinator for the VA Rocky Mountain Healthcare Network based out of Fort Harrison, Mont.

Chief Tim J. Davis provided welcoming remarks. Tribal Chaplain Alice Jo Ricketts offered a prayer, and Councilman and veteran David Merrill Jr. was in attendance throughout the week.

The goal of the training was to help attendees understand programs available for returning armed services members, veterans, and their families under the new PACT Act of October 2022. The Act expands healthcare and benefits for veterans exposed to toxic substances during military service. Minnie Martin, secretary for Anishinaabe Ogitchedaw Veterans Warrior Society, said Richardson and other tribal veterans started a program decades ago to assist tribal veterans nationwide with navigating the VA system of healthcare.

"... Buck announced that he was retiring... I informed David Merrill and told him that I was going to go to the Ziibiwing Center and buy a Pendleton blanket for him," Martin said. "We chose one with a limited edition of the Tribal emblem."

Merrill also got a challenge coin, a small coin embossed with the unit's emblem, to present to Richardson.

Richardson said he was "deeply moved" by the honor.

"My heart soared as I saw the Saginaw Chippewa logo put around my shoulders," Richardson said, mentioning a military background runs in the family. "My sister was born in Mount Pleasant in 1967 while my old man was in Saigon serving on an 18-month tour. She was 11 months old before he ever had a chance to meet her..."

# District 3: At Large

# Tribal voting 500-foot radius, non-interference zone

Ordinance 4, Section 19. Prohibition against interference with Elections.

On Election Day for any Council election, including any Primary, General, Special, Run-Off or removal Election, a person, including any Tribal official, employee or representative, shall not:

(a) On any land owned by the Tribe or held in trust for the Tribe, excluding property leased for residential use:

(i) post, display or distribute any material that directly or indirectly makes reference to an election, a candidate or a ballot question (This subsection does not apply to official material that is required by law to be posted, displayed or distributed in a polling place on election day);


(ii) solicit, persuade or endeavor to persuade, intimidate or threaten a person to vote for or against any particular candidate or for or against any ballot question that is being voted on at the election; or

(iii) either directly or indirectly, for the person's own benefit or on behalf of any other person, receive, agree or contract for valuable consideration for voting or agreeing to vote, or inducing or attempting to induce another to vote, or for refraining or agreeing to refrain, or inducing or attempting to induce another to refrain, from voting; or

(iv) either directly or indirectly, give, lend or promise valuable consideration to or for any person as an inducement to influence the manner of voting by a person relative to a candidate or ballot question or as a reward for refraining from voting; or

(b) loiter within a building where a polling place is located or within 500 feet of any entrance to such building, including any parking areas adjacent or appurtenant to such building; or

(c) directly or indirectly utter or address any threat or intimidation to an election official or other person authorized to administer or enforce election laws or to conduct, oversee or monitor an election or to assist in the carrying out of such duties, with the intent to induce such person to do any act not authorized by law or to refrain or delay in the performance of any duty imposed by law.






