Annual Tribal-State Summit highlighted with honoring education and art

PUBLIC RELATIONS DEPARTMENT

Michigan's 12 federally recognized tribal nations were invited to the 2025 Tribal-State Summit, in partnership with the State of Michigan through the Office of the Governor, on Friday, Oct. 11.

The Summit was held at the Woldumar Nature Center in Lansing, Mich. The annual summit is held to continue to open up dialogue between the sovereign tribes and the State, while identifying key opportunities and finding ways to collaborate to bring growth and sustainability to Michigan tribes and the State.

The day began with the opportunity for tribal leaders to have one-on-one meetings with Michigan Gov. Gretchen Whitmer.

SCIT was welcomed by Gov. Whitmer and was represented by Tribal Council members: Sub-Chief Luke Sprague, Secretary Jennifer Wassegijig, Sgt.-at-Arms Christina Otto, Chaplain Alice Jo Ricketts and Brad Bennett.

This year's dialogue focused on prioritizing the finalizing of several key negotiations between SCIT and the State of Michigan. The goal is to complete and implement these before the governor finishes her final term in 2026.



The Council also placed an Initiative's educational emphasis on meaningful consultation and bringing tribal nations to the table before decisions are made. This will ensure tribes can weigh in on how to best complete the work necessary for desirable outcomes from all parties involved.

Tribes were then given an opportunity for an open round-table forum with tribal liaisons and administrative staff members from more than 25 State departments. This time allowed for tribal leaders to share recommendations in improving relationships between State departments and tribal nations. It also opened up discussions about how to better serve tribal nations and ensure they have opportunities to secure crucial resources for their communities.

The day was then highlighted by a special presentation in honoring Indigenous education with a focus around Indigenous Education

materials presented in a well-rounded and curated box of educational resources. The purpose in sharing these resources is to assist in helping educators confidently and effectively teach about Indigenous histories, cultures, and contemporary contributions.

The overall goal is to continue to create a message that encourages everyone to explore these resources

and learn about the rich history of Michigan's tribal nations. Please visit the Indigenous Education Initiative's website at www.ieimi.org for all materials.

Gov. Whitmer was also excited to announce the appointment of SCIT Member Melissa Isaac to the Native American Heritage Fund Board. This board was established by the

Nottawaseppi Huron Band of the Potawatomi (NHBP).

The structure of the board consists of two NHBP seats, two governor-appointed positions, and one Michigan Department of Civil Rights seat.

"I am deeply honored to receive an appointment from Governor Whitmer to serve on the Native American Heritage Fund Board," Isaac said.

"This board, established by the Nottawaseppi Huron Band of the Potawatomi, exists to 'promote positive relationships between public and private K-12 schools, colleges, universities, local units of government, and Michigan's federally recognized Native American Tribes."



Saginaw Chippewa Indian Tribe provides remarks on the passing of longtime leader of Indian Gaming Association, Ernie Stevens Jr.



With heavy hearts, the Saginaw Chippewa Indian Tribe and its Tribal Council provided remarks about the passing of longtime leader of Indian Gaming Association, Ernest "Ernie" L. Stevens. Stevens passed away on Friday, Sept. 26.

Stevens was a recognized and respected leader of the Oneida Nation in Wisconsin and his voice shown through as a loving son, brother, husband, father, grandfather, and friend.

Frank J. Cloutier, current Tribal Councilman and former chief, recalled attending one of the National Congress

of American Indians conventions as Stevens was actively running for the chairmanship.

"Ernie was young, energetic and full of hope for the future. He met with me and asked for my support," Cloutier said. "I was very happy to provide that support on behalf of our leadership during that time and have never regretted it. We have worked together on so many issues over the years and have banded together to support our fellow Native community."

Cloutier commended the leadership Stevens demonstrated in Indian Country but said he was humbled to refer to Ernie as a dear friend.

Tribal Councilman David Merrill Jr. said Indian Country lost a true leader with the passing of Stevens.

"Our community has lost a guiding fire, and Ernie's absence will be felt greatly throughout the gaming industry. His work has allowed our nations to gain power and influence to advocate for important priorities of our tribes," Merrill said. "One moment that has stayed with me was his ability to connect with a story and with you as an individual. He was an extremely busy at the tradeshows and with the Indian Gaming Association, but made time to visit and connect with fellow tribal leaders."

Merrill said he remembers how Stevens carried with him an ability to remember key figures with Saginaw Chippewa historical leadership and the relationships he made with them.

"He remembered lots of our past tribal leadership who served. Often with generations, differences can be disconnected and that's where Ernie stood apart," Merrill said. "He didn't just speak at younger people, he truly listened. He sought out our perspectives on where Indian Country was headed and how we could remain relevant in a rapidly changing world."

Merrill said he observed many occasions where Stevens remained true to his core values of tribal sovereignty, youth advocacy, and community development.

"His engagement was not symbolic; it was sincere and deeply rooted in respect for others," Merrill said. "I will miss his mentorship and I offer my sincere condolences to his family: Miigwetch and thank you for sharing him with our Tribe and Indian Country."

Ernie L. Stevens Jr.

July 5, 1959 - September 26, 2025

Ernie L. Stevens Jr., a loving son, brother, husband, father, grandfather, and friend, passed away on Friday, Sept. 26, 2025. He gave his life in service to his family, his Nation, and to Indigenous peoples everywhere. While Ernie was a citizen of the Oneida Nation in Wisconsin, he was known far beyond his home community for his dedication to tribal sovereignty, youth advocacy, and community development.

To the people who knew him, he was someone who always left an event last because he had to stop and talk to everyone. He enjoyed telling a long-winded story but loved hearing stories from others just as much. No matter where he was, he took time to share how proud he was of his children, how much he loved his wife, and how he was shaped by the strong women who raised him: most notably, his mother and grandmother.

From his earliest years, Ernie carried the teachings of his mother's activism. At just 13 years old, he stood alongside members of the American Indian Movement at Wounded Knee, learning what it meant to fight for his people.

In his later years, his grandmother would establish a home near Duck Creek in Oneida for her family. It is here that Ernie would build on this homestead and provide a space for everyone to feel welcome. A homestead built on many stories. Born in Los Angeles, and raised in Milwaukee, for many years, he enjoyed the hustle and bustle of the big city. But he was most fond of the quiet days playing cribbage in his front yard with his wife.

Ernie earned his associate degree from Haskell Indian Junior College in 1983, alongside his wife. Haskell held a special place in his family's story, as his grandmother, Maria Hinton, had also attended when it was still a boarding school.

In time, all five of Ernie and Cheryl's children would follow in their footsteps, each attending Haskell and playing basketball there. Over the years, Ernie could often be found in the stands cheering on the games, giving guest lectures, handing out T-shirts, and showing up in every way possible to support the students. He loved Haskell deeply and often spoke of the mentors who believed in him before he believed in himself.

Ernie earned his bachelor's degree in criminal justice from Mount Senario College in 1996, where he was active on the Indian student council. During that time, he also served briefly as a reserve officer for the Barron County Sheriff's Department. He often spoke of how a kind soul gifted him his officer's belt during a time of need, a gesture he treasured and carried with him throughout his life. While still in

northern Wisconsin, Ernie also became the youngest coach in the state, leading both basketball and soccer at UW-Barron. This marked his transition from player to coach, a path that grew into a lifelong commitment, hosting countless basketball camps, funding travel to tournaments, sponsoring jerseys, and supporting student-athletes across the country.

After graduation, Ernie returned home to run the Oneida Outreach Program at the Norbert Hill Center, where community members could earn college credit from Mount Senario College. He reflected on this time often and with pride, remembering how he leaned on community members to serve as educators, expanding access to opportunities that had not always been available. It was during this program that his mother and stepmother formed a lasting friendship, a reminder to him of how education could build bridges within community.

With Cheryl's steady encouragement, Ernie later continued his own learning journey, earning a master's in management from the University of Phoenix in 2021

Education did not always come easily to Ernie, but with the steadfast support of his wife and the guidance of dedicated mentors, he persevered and found success. What fueled him most was his passion for athletics: Boxing, basketball, football, baseball, and softball, which carried him across the country, earning championships, trophies, and jackets, but most importantly, forging lifelong friendships.

His own struggles with academics gave him a deep respect for the power of education, and he became a strong advocate for others to pursue their studies. At the same time, because athletics had been a lifeline during his most challenging times, he committed himself to supporting the athletic journeys of young people throughout Indian Country. This dedication ultimately led him become co-founder of the Soaring Eagle Foundation, a tribute to the Soaring Eagle Boxing Club and an organization created to help Indigenous youth follow their dreams both on and off the court.

From 1993 to 1999, Ernie served as a councilman for the Oneida Nation Business Committee, where he worked to strengthen economic opportunity and improve services for his community through self-determination. His leadership quickly extended to the national stage, being nominated and elected as first vice president for the National Congress of American Indians (NCAI) in 1999.

In 2000, he was elected chairman of the Indian Gaming Association (IGA), a position he would hold for 24 years. At the time of his passing he was serving his 13th term, having been reelected in April 2025. Under his leadership for IGA, Ernest helped guide tribal gaming through unprecedented growth, making tribal government gaming the largest segment of the U.S. gaming industry. The success of gaming meant new schools, better health

care, infrastructure, elder services, and youth programs for tribal nations across the country.

Ernest also served on the boards of the National Center for American Indian Enterprise Development, the Nike N7 Foundation, Native Forward, the Center for Native American Youth, and the Boys & Girls Club's Native American advisory board.

He was inducted into The Boys & Girls Club Alumni Hall of Fame in 2012, the American Gaming Association's Hall of Fame in 2015 and honored by many other organizations for his tireless advocacy. Throughout his career, Ernest worked with countless tribal leaders, members of Congress, and global organizations, but he never forgot who he represented. Whether he was testifying before Congress, addressing a national conference, or sitting in a tribal gym, he carried himself as a warrior for the people.

To Indian Country, he was an advocate, mentor, and friend. At home, he was Cheryl's best friend of 47 years, a devoted father, and a loving grandfather. Of all his titles and responsibilities, being Papa was the role he cherished above all others. To his 20 grandchildren, he leaves behind a legacy of endless love: Nyah, Patricia, MarjaRia, Ernest, Tierra, Brandon Jr., Daniel, Sierra, Marley, Markane, Mason, Lucia, Riddek, Orion, Lennon, Isley, Maria Grace, Luka, Abi, and Quade. Whether he was picking on them, giving them bubble gum, or just settling for a fist bump, they endured his teasing with groans and felt his love with each breath that he was near.

He is survived by the love of his life, Cheryl Rose; his five children: Brandon (Ashlee), Ernie III (Stephanie), Margaret, Maria, and Lois (Paul); his siblings: Kelly (Shelly), Toni (Doug), Mike (Tommi), Pam, Jennifer, David, Michelle (Tehassi), and Apache (Brian); and his mother, Marjorie.

He is preceded in death by his grandmother, Maria Hinton; his father, Ernie Stevens Sr.; his stepmother, Patricia; his little brother, Coleman; and his beloved German Shepard, Luke.

Ernie Stevens Jr. was more than a leader; he was family to us all. As we honor his journey, we remember his laughter, his bright presence in every room, his willingness to listen, and his unwavering commitment to our people.

May we continue his work by living out the values he held dear: family. community. sovereignty.

Family and friends were invited to gather for visitation on Friday, Oct. 3, from 4 to 8 p.m. at the Oneida Nation Elementary School (Oneida, Wisc.).

Funeral services were be held on Saturday, Oct. 4, at the Oneida Nation Longhouse. Burial followed at Oneida Sacred Burial Grounds Cemetery.

Nimkee Clinic receives endowment from CMU **AEDs** new

Nimkee Memorial Wellness Center has been chosen for the 2025 recipient of Pulse3 Endowment, from Central Michigan University's College of Medicine, bringing two new AVIVE Automated External Defibrillators (AEDs) to the SCIT community.

The Pulse3 Endowment for Cardiovascular Health exists within the CMU College of Medicine by virtue of a \$500,000 gift from the former Pulse3 Foundation in Saginaw, Mich.

Dr. Steven Vance, associate dean of clinical education from the CMU College of Medicine, visited the Nimkee Clinic on Oct. 23 as the clinic received the AEDs.

According to Vance, the endowment is designated to support community and CMU College of Medicine-based health initiatives and programs within the Great Lakes Bay Region.

"In particular, we support initiatives that increase the

availability of educational and community-based research programs designed to prevent cardiovascular disease and injury, improve health, and enhance quality of life," Vance said.

Vance also wished to express gratitude for Nimkee's longstanding support of CMU's medical student programs at the College of Medicine.

"Since 2016, CMU students have rotated at (Nimkee) and consistently rate the experience as outstanding," Vance said.

As part of their fundraising

effort, the College of Medicine hosts an annual "Shocks and Saves" charity hockey game. Funds raised at this event support the AED grant program.

On Nov. 21, 2005, Detroit Red Wings player Jiri Fischer suffered a sudden cardiac arrest on the ice during a televised game and was successfully resuscitated by prompt CPR and AED usage by the Red Wings medical staff.

The Pulse3 Foundation, in conjunction with Fischerinitiated charity hockey games,

"Shocks and Saves," raises funds to place AEDs in public venues and to start CPR for the general population.

"Now entering its 17th year, Shocks and Saves has raised over one million dollars for the purchase of AEDs and delivery of training to our community," Vance said. "To date, Pulse3 has trained over 20,000 people in CPR and AED usage.

"Since 2008, Pulse3 has donated over 400 AEDs to the schools, churches, and nonprofits in the Great Lakes Bay Region and these AEDs have saved at least 20 lives. Overall survival for cardiac arrest in our region is nearly 15 percent; almost double the statewide survival."

Lindsay Drumm, strategic grant specialist for SCIT, said she was approached in early January for assistance in securing the funding for the AEDS.

Drumm said Tribal Fire Chief Fred Cantu, Vinnie Kequom (assistant director of IT), and David Chatfield (safety coordinator) approached the Office of Grants and Contracts for assistance in securing the

funding, as several departments had expressed need for additional AED units.

"When we first contacted Dr. Vance and Angela Appold from the Central Michigan University College Medicine regarding the Pulse3 Endowment, we learned the program initially supported only Zoll AEDs, a brand not currently used in our Tribal buildings," Drumm said.

"Recognizing the importance of consistency in life-saving equipment, when every minute counts, we emphasized the need for all responders to operate the same AED brand (Avive) found throughout our Tribal buildings," Drumm said. "After reviewing our request and conducting further research, Dr. Vance generously donated two Avive AEDs to the Nimkee Memorial Wellness Center."

Drumm said a special thank you goes out to "the incredible staff at Nimkee," especially Health Educator, Robyn Grinzinger, for her help and collaboration in assisting with this grant application."

Guests were also treated to a release of 11 monarch butterflies. The butterflies grew in their chrysalis for six weeks before emerging. The chrysalis is the pupal stage in a butterfly's life cycle, where the caterpillar undergoes metamorphosis to transform into a butterfly.

The event was also made possible by contributions from the Saginaw Chippewa Tribal College and Planning Department.

On July 22, the National Association of Tribal Historic Preservation Officers (NATHPO) announced the Ziibiwing Center is one of the recipients for its 2025 Protecting Native Places Grants.

NATHPO announced this year marks a "historic camp in September.

expansion" of the program, with an increase in the number of recipients and size of the grants.

The Ziibiwing Center's Tribal Historic Preservation Office received a \$40,000 grant which, according to Marcella Hadden, tribal historic preservation officer, will be used for two interns until May 2026 and aid towards a fasting

"The Michigan Department of Natural Resources and the Saginaw Chippewa Indian Tribe of Michigan co-manage the ezhibiigaadek asin (Written on Stone) at the Sanilac Petroglyphs Historic State Park near Cass City, Michigan," said William Johnson, curator/office manager for the Ziibiwing Center. "... The grant will continue to assist the State

management and to protect this sacred site." Johnson continued, "This

grant helps to preserve our cultural places, promote our cultural heritage and honor our connectedness to Mother Earth. with genuine support from NATHPO."

Twenty-five **THPOs** received the grants this year, and the amount increased from \$5,000 to \$40,000.

"Tribal historic preservation officers spend their days

performing the sacred work of protecting sacred places and cultural resources," said NATHPO Executive Director Dr. Valerie Grussing in a media release. "NATHPO is proud to provide direct support for that work through our Protecting We continue to be blessed Native Places grants. We are grateful for the support of the Mellon Foundation, without which we could not have expanded the reach and strength of that support, and we look forward to continuing and growing this program in the years to come."





On Tuesday, Sept. 30, the Saginaw Chippewa Tribal community recognizes Orange Shirt Day, which honors and remembers Indigenous children who were taken from their families and put into residential schools. Orange Shirt Day also symbolizes "Every Child Matters" and wearing orange raises awareness for those children that were taken and never made it back home to their families.

Council Resolution assists Tribal grandparents, extended family through revisions

Keeping Native children with Native families is a natural extension and of tribal culture and an assertion of tribal sovereignty.

The Tribal Council directed the Legal Department to work with several departments to develop Tribal Code revisions that recognize the importance of grandparents and extended family to Tribal Member children.

Tribal Resolution 25-066 ensures that tribal grandparents and extended family have the ability, if necessary, to petition the Tribal Court for visitation of their tribal member grandchild, niece, nephew

Departments taking part in the development of the revised Grandparents Code included the Saginaw Chippewa Tribal Court, Anishinaabeg Child and Family Services, and Behavioral Health. The review process also was strengthened through the support given by

the Tribal Health Board and the Elders Advisory Board.

After consultation, the Legal Department forwarded the proposed changes to the Tribal Children's Code to Tribal Council for their review and approval given on March 12, 2025.

Resolution 25-066 states: "Whereas: The Tribal Council finds that the Title II Amendment for visitation rights for grandparents and extended family members as provided herein is in the best interests of the Tribe."

District Three Council Member Frank Cloutier said Grandparent & Extended Family Visitation Rights, as defined in the Resolution within the Title II Children's Code, was an essential act given, both culturally and traditionally, extended family members such as grandparents assist in rearing tribal children.

"Much too often western culture finds its way into our daily lives and we lose sight of our traditional habits," Cloutier said. "Tribal Council responded to the call of our members when addressing these rights so we can ensure our way of life remains consistent with our day-to-day lives."

The five page Resolution can be found in the Tribal Members section at www. sagchip.org. The 68-page document entitled "Saginaw Chippewa Tribal Law TITLE II Children's Code" and the provision regarding grandparent and extended family visitation rights (Chapter 2.13) can be found in its entirety on the SCIT website as amended June 11, 2025.

as the Native American outreach specialist.





- 1 cup wild rice
- ½ cup sunflower seeds (shelled)
- ½ cup maple syrup
- ¼ cup fresh blueberries
- ¼ cup fresh raspberries (or strawberries)



Andahwod hosts open discussion featuring Tribal elders' conversation with MDHHS

On Oct. 22, the Andahwod Continuing Care Community & Elder Services hosted an open discussion format where Tribal elders were given an opportunity to have a candid conversation with State of Michigan. Elders shared their thoughts on needs and services for the development of Michigan's next three year State Plan on Aging.

Elders Advocate Sheligh said Jackson 20 elders attended the conversation with Michigan Department of Health and Human Services (MDHHS) Bureau of Aging, Community Living, Supports (ACLS Bureau).

"These strategic planning sessions will help formulate a statewide needs assessment," Jackson said. "Participants highlighted the importance of keeping elders in their homes, wellness checks, regular home safety measures, and more extended care options to support aging with dignity."

MDHHS State Assistant Administrator Tammy Lemmer served as facilitator and was joined by her colleague Candice Dubbs from the ACLS Bureau (formerly the Aging and Adult Services Agency, or AASA). Region 7 Area Agency on Aging staff

to highlight services offered to

elders through their programs. Lemmer said State Units on Aging are tasked under the Older Americans Act with developing and administering a multi-year state plan on aging that provides goals and objectives related to assisting older residents, their families,

and caregivers in their states.

"A critical element of the state plan development is a statewide needs assessment," Lemmer said. "These efforts include key informant interviews, including one to be held with Tribal elder services directors, community conversations with adults and caregivers, and a survey of older adults/elders."

October recognizes Domestic Violence Awareness

Lemmer continued, "The conversations and surveys are intended to help the State Unit on Aging better understand the needs and priorities of elders by hearing directly from them about their knowledge and experiences with elder services through the Tribe and/or the local Area Agency on Aging."

Isabelle Welsh, MDHHS tribal government services and policy departmental specialist, said SCIT was selected among the 12 federally-recognized tribes in Michigan. Other efforts are taking place at the Keweenaw Bay Indian Community and the Bay Mills Indian Community.

"Our goal is to ensure the tribal voices of elders and caregivers are heard and that's why we are hosting a series of community conversations across the state," Welsh said. "These sessions are designed to gather input from adults aged 55-60 (and older) and their caregivers about their needs, experiences, access to resources, and any barriers they may face."

Megan Twardecki, contracts and billing director, said Region VII's relationship with SCIT helps them remain aware of and adapt to culturally specific needs.

"Our goal is to ensure relevancy and eliminate risks of disparity in the availability and effectiveness of our services," Twardecki said.

Gayle Ruhl, director for Andahwod, said she appreciated members of the Elders Advisory Board and the Saginaw Chippewa Tribal Health Board for attending.

"For those that were not able to attend, there will be a virtual

meeting planned for those who missed the in-person session or those who would like to offer more input," Ruhl said.

The virtual session is set for Thursday, Nov. 13 at 6 p.m. For more information and a link to attend the meeting, please call (517) 230-9707.
